JOB TITLE: Code Inspector I

REPORTS TO: Assistant Director of Planning

To perform this job successfully, an individual must be able to perform the essential job functions satisfactorily. JOB SUMMARY:

Inspects new construction and remodeling projects for compliance with the Garrett County Building Code and other codes and regulations adopted by the County. The inspector also conducts inspections of stormwater management controls.

ESSENTIAL JOB FUNCTIONS (not all inclusive):

- Inspects new construction and remodeling projects for compliance with building codes. This includes inspecting footings, foundations, framing, insulation, and final inspections for occupancy approval.
- Maintain a thorough knowledge of all adopted building codes and stormwater regulations and stay abreast of code changes.
- Maintain a working knowledge of construction techniques and materials.
- Maintain records of all inspections and correction notices in permit databases.
- Conducts inspection of stormwater controls and triennial stormwater inspections.
- Respond to questions from the public and contractors.
- Collaborate with staff on potential changes to the County Building Codes.
- Other duties may be assigned as required.

QUALIFICATIONS:

The requirements listed below are representative of the knowledge, skill, and/or ability required.

Education and Experience:

- High School diploma or equivalent.
- Experience in the construction industry including construction supervision, code administration, codes enforcement or building inspections.

Knowledge, Skills, and Abilities:

- Knowledge of construction techniques, designs, and materials.
- Knowledge of building codes and the ability to interpret and apply the regulations to residential, commercial, and industrial projects.
- Knowledge of the practical application of County ordinances, permitting processes, and associated State laws, particularly those related to stormwater management.
- Ability to read and interpret building & grading plans.
- Ability to manage data in a permit database.

- Ability to communicate clearly, both verbally and in writing with the public, contractors, and engineers.
- Ability to perform basic mathematical functions related to plans review.

Certificates and Licenses:

- Valid driver's license
- ICC certification is recommended.

PHYSICAL DEMANDS and WORK ENVIRONMENT:
