Request for Fiscal Year 2025 County Property Tax Abatement granted under the Annotated Code of Maryland §7-502.

The Board of County Commissioners, on a motion by Commissioner Savage, which was seconded by Commissioner Tichnell, and made unanimous by Chairman Edwards, approved a real property tax abatement of the total amount of \$47,662.56 for Fiscal Year 2025 for the following properties owned by Garrett County Community Action Committee, Inc. that serve a public purpose with limited or no revenue producing potential:

On a motion by Commissioner Tichnell, which was seconded by Commissioner Savage, and made unanimous by Chairman Edwards, the Public Meeting and closed and the Public Hearing was opened at 4:36 p.m.

- 7. **PUBLIC HEARING:** Revisions and Adoption on the following Ordinances:
 - <u>Building Code Ordinance</u> adopting and implementing the 2021 International Building Code, Residential Code and Energy Conservation Code. Ordinance would require engineered, stamp building plans with specific criteria to approve other plans.
 - Mechanical Code Ordinance adopting The International Mechanical Code 2018 published by the International Code Council. Ordinance would require permits for HVAC work.
 - Community Reinvestment & Repair Fund Ordinance adopting and implementing Community Reinvestment and Repair Fund for Garrett County, Maryland

The Cannabis Reform Act passed by the Maryland General Assembly during the 2023 session required Counties to establish a Community Reinvestment and Repair Fund. The requirement is established in the Maryland Code, Alcoholic Beverage and Cannabis Article, §1-322. This fund is to be administered, at the state level, by the State Comptroller and must be used to serve underserved communities determined by the State Office of Social Equity. The fund will consist of sales and use tax revenues distributed to the Fund under §2-1302.2 of the Tax-General Article. Each County is required to establish its own Community Reinvestment and Repair Fund.

Maryland imposes a 9% state sales tax on adult use cannabis with 35% or these proceeds being allocated to the Community Reinvestment and Repair Fund. Garrett County Community Reinvestment and Repair Fund allocation is .042% (\$17,916.19 - July 1-Sept. 30, 2023).

These funds may be used for funding community-based initiatives intended to benefit low-income communities or that serve disproportionately impacted areas. The funds may not be used for law enforcement agencies or activities, or to supplant funding that otherwise would be appropriated for preexisting local government programs.
