BOARD MEETING MINUTES

September 10, 2024

APPROVAL OF MINUTES:

The minutes for the June 4th, 2024 meeting was approved on a motion made by Chuck Nolan, seconded by James Moore, and made unanimous by Randy Glotfelty. The July and August meetings were canceled due to no business to discuss.

ELECTION DIRECTOR REPORT:

Steve introduced, Sharon Slovak, the County Technician for the General Election, to the Board.

There were 205 new voter registrations and 175 removals in July and August combined. Of the removals many were due to the confirmation mail process and voters who are now deceased.

Steve has completed post-election maintenance on the voting equipment.

On August 20th, Steve attended the MAEO (Maryland Association of Election Officials) meeting at Owings Mills, Maryland. The meeting was primarily focused on Election Security. New Officers and Board Members were elected.

Steve spoke at a breakfast of the Wise Men Club at Perkins Restaurant on August 21st. Steve supplied information on election dates and procedures.

On August 27th, Steve was the guest speaker at the GGBA (Garrett County Business Association) Breakfast Meeting at Penn Alps Restaurant in Grantsville. There were approximately 25 attendees. Steve provided information on the election process in general.

The ballot test decks were received at the office today, September 10th. Steve and Sharon, County Technician, ran the test decks and approved them for printing.

Upcoming dates are as follows:

- September 16th The Mail-In Ballot Drop Boxes will be delivered.
- September 19th The first mailing of Mail-In Ballots will be sent out.
- September 21st Election Judge Refresher Training will be held at Garrett College in the Performing Arts Center at 9:00 a.m. Commissioner Edwards will give the welcoming address. Sheriff Bryson Meyers will discuss Election Security.
